V. New Business

A. Resignation. RECOMMENDED MOTION:

Salary is based upon the **Teaching Assistant Scale, Step 5.**” (RB) (ENC)

3. **Appoint Temporary Part Time Bus Mechanic Foreman. RECOMMENDED MOTION:** “that upon the recommendation of the Superintendent, **Donald Preischel**, be appointed as a temporary part time Bus Mechanic Foreman in the Transportation Department effective November 9, 2011. Salary is based upon the **CSEA Contract, Level 13, Step L10.**” (LA)

Note: Mr. Preischel will be filling in on an as needed basis in the medical absence of Mr. Genco.

- C. **Increase Hours for Bus Driver. RECOMMENDED MOTION:** “that upon the recommendation of the Superintendent, the hours for Bus Driver, **Juliann Blencowe** be increased from 1.5 per day to 5.0 per day.” (LA) (ENC)

- D. **Increase Hours for Bus Driver. RECOMMENDED MOTION:** “that upon the recommendation of the Superintendent, the hours for Bus Driver, **Vincent Vacco** be increased from 6.5 per day to 6.75 per day.” (LA) (ENC)

- E. **Approve AFS Overnight Trip. RECOMMENDED MOTION:** “that upon the recommendation of the Superintendent, the AFS overnight trip to Montpelier High School in Montpelier, VT January 26-29, 2012 be approved.” (RB) (ENC)
